- Closely monitor any forthcoming Al-related legislation stemming from the Georgia Senate Al Study Committee's recommendations for potential to significantly impact business operations, innovation, and regulatory compliance across industries.

## Education & Workforce Development

- **Advocate** for continued robust funding of Clayton State University and Southern Crescent Technical College to equip students with skills for high-demand industries. This includes support for expanding apprenticeship programs that create pathways from non-credit to credit-based education, ensuring workforce readiness for modern industries.
- Support initiatives that focus on developing, keeping, and attracting a competitive, globally oriented workforce, critical to keeping Georgia's economy dynamic and diverse.
- Push for stable and adequate funding for the Dual Enrollment program, ensuring that Fayette County students have access to college-level coursework and technical training, preparing them for both higher education and direct entry into the workforce.

# Taxes & Business Regulations


